# Starting an LLC in Wisconsin is easy, just follow these simple steps:

# STEP 1: NAME YOUR WISCONSIN LLC

Choosing a company name is the first and most important step in starting your LLC. Be sure to choose a name that complies with Wisconsin naming requirements and is easily searchable by potential clients.

### 1. Follow the naming guidelines:

- Your name must include the phrase "limited liability company" or one of its abbreviations (LLC or L.L.C.).
- Your name **cannot include** words that could confuse your LLC with a government agency (FBI, Treasury, State Department, etc.).
- Restricted words (e.g. Bank, Attorney, University) may require additional paperwork and a licensed individual, such as a doctor or lawyer, to be part of your LLC.
- **2.** Is the name available in Wisconsin? Make sure the name you want isn't already taken by doing a <u>name search</u> (<a href="https://www.wdfi.org/apps/CorpSearch/NameAvailability.aspx">https://www.wdfi.org/apps/CorpSearch/NameAvailability.aspx</a>) on the State of Wisconsin's website.
- 3. Is the URL available? We recommend that you check to see if your business name is available as a <u>web domain</u> (<a href="http://www.anrdoezrs.net/click-5628080-10815550?sid=httsl+llc+wisconsin+webdomain">http://www.anrdoezrs.net/click-5628080-10815550?sid=httsl+llc+wisconsin+webdomain</a>). Even if you don't plan to make a business website today, you may want to buy the URL in order to prevent others from acquiring it.

# STEP 2: CHOOSE A REGISTERED AGENT IN WISCONSIN

You are required to nominate a Wisconsin Registered Agent for your LLC.

<u>What is a Registered Agent? (.../../what-is-a-registered-agent)</u> A registered agent is an individual or business entity responsible for receiving important legal documents on behalf of your business. Think of your registered agent as your business' point of contact with the state.

Who can be a Registered Agent? A registered agent must be a resident of Wisconsin or a corporation, such as a <u>registered agent service</u>, (.../../registered-agent/should-I-use-a-registered-agent-service) authorized to transact business in Wisconsin. You may elect an individual within the company including yourself.

# STEP 3: FILE THE WISCONSIN ARTICLES OF ORGANIZATION

To register your LLC, you will need to file the Articles of Organization with the state of Wisconsin. This can be done online or by mail.

When filing, you will need to state whether your LLC will be member-managed or manager-managed. We recommend <u>learning more (../../members-vs-managers-managed-llc)</u> about these two options before you file.

# STEP 4: CREATE AN OPERATING AGREEMENT

An operating agreement is not required in Wisconsin, but it's a good practice to have one.

What is an operating agreement? An operating agreement is a legal document outlining the ownership and operating procedures of an LLC.

Why are operating agreements important? A comprehensive operating agreement ensures that all business owners are on the same page and reduces the risk of future conflict.

# STEP 5: GET AN EIN

<u>What is an EIN? (.../../what-is-an-ein)</u> The Employer Identification Number (EIN), or Federal Tax Identification Number, is used to identify a business entity. It is essentially a social security number for the company.

Why do I need an EIN? An EIN is required for the following:

- To open a business bank account for the company
- For Federal and State tax purposes
- To hire employees for the company

Where do I get an EIN? An EIN is obtained from the IRS (free of charge) by the business owner after forming the company. This can be done online or by mail.

### **NOTE**

FOR INTERNATIONAL APPLICANTS: you **do not need an SSN** to obtain an EIN. <u>Learn more here (.../.../what-is-an-ein/how-to-get-an-ein-as-a-foreign-person)</u>.

# **Protect Your Business & Personal Assets**

### BUSINESS BANKING FOR PERSONAL ASSET PROTECTION

Using dedicated business banking and credit accounts is essential for personal asset protection.

When your personal and business accounts are mixed, your personal assets (your home, car, and other valuables) are at risk in the event your LLC is sued. In business law, this is referred to as <u>piercing your corporate veil (/maintain-llc-corporate-veil)</u>.

You can protect your business with these two steps:

### 1. Opening a business bank account:

- Separates your personal assets from your company's assets, which is necessary for personal asset protection.
- Makes accounting and tax filing easier.

### 2. Getting a business credit card:

- Helps you separate personal and business expenses.
- Builds your company's credit history, which can be useful to raise capital later on.

### **GET INSURANCE**

Business insurance helps you manage risks and focus on growing your business. The most common types of business insurance are:

- <u>General Liability Insurance (/general-liability-insurance)</u>: A broad insurance policy that protects your business from lawsuits. Most small businesses get general liability insurance.
- <u>Professional Liability Insurance (.../../professional-liability-insurance)</u>: A business insurance for professional service providers (consultants, accountants, etc.) that covers against claims of malpractice and other business errors.
- <u>Workers' Compensation Insurance (/what-is-workers-compensation)</u>: A type of insurance that provides coverage for employees' job-related illnesses, injuries, or deaths. In Wisconsin, businesses with three or more employees, excluding business owners, are required by law to have workers compensation insurance. <u>Get a free quote with ADP.</u> (<a href="https://explore.adp.com/ins-wc-truic">https://explore.adp.com/ins-wc-truic</a>)

### PROPERLY SIGN LEGAL DOCUMENTS

Improperly signing a document as yourself and not as a representative of the business can leave you open to personal liability. When signing legal documents on behalf of your company, you could follow this formula to avoid problems:

- 1. Formal name of your business
- 2. Your signature
- 3. Your name
- 4. Your position in the business as its authorized representative

This ensures that you are signing on behalf of your LLC and not as yourself.

# WISCONSIN BUSINESS PERMITS & LICENSES

### Do I need business licenses and permits?

To operate your LLC you must comply with federal, state, and local government regulations. For example, restaurants likely need health permits, building permits, signage permits, etc.

The details of business licenses and permits vary from state to state. Make sure you read carefully. Don't be surprised if there are short classes required as well.

Fees for business licenses and permits will vary depending on what sort of license you are seeking to obtain.

- Local: Contact your local county clerk and ask about local licenses and permits.

# WISCONSIN LLC TAX REQUIREMENTS

Depending on the nature of your business, you may be required to register for one or more forms of state tax.

Sales Tax

If you are selling a physical product, you'll typically need to register for a <u>sellers permit (.../.../taxes/wisconsin-sales-tax#sellers)</u> through the Wisconsin Department of Revenue website.

This certificate allows a business to collect sales tax on taxable sales.

Sales tax, also called "Sales and Use Tax," is a tax levied by states, counties, and municipalities on business transactions involving the exchange of certain taxable goods or services.

**Employer Taxes** 

If you have employees in Wisconsin, you will need to register for <u>Unemployment Insurance Tax</u> (<a href="https://dwd.wisconsin.gov/ui201/">https://dwd.wisconsin.gov/ui201/</a>) through the Wisconsin Department of Workforce Development. You will also need to sign up for <a href="mailto:Employee Withholding Tax">Employee Withholding Tax (https://www.revenue.wi.gov/DOR%20Publications/pb166.pdf">pb166.pdf</a>) through the Wisconsin Department of Revenue.

# FEDERAL LLC TAX REQUIREMENTS

Most LLCs will need to report their income to the IRS each year using:

- Form 1065 Partnership Return (https://www.irs.gov/forms-pubs/about-form-1065-us-return-of-partnership-income) (most multi-member LLCs use this form)
- Form 1040 Schedule C (https://www.irs.gov/forms-pubs/schedule-c-form-1040-profit-or-loss-from-business) (most single-member LLCs use this form)

### FILE YOUR LLC ANNUAL REPORT

Wisconsin requires LLCs to file an annual report with the Wisconsin Department of Financial Institutions.

Due Date: Due by the end of the quarter in which an LLC was formed.

Late Filings: Wisconsin dissolves LLCs within one year for failure to file an annual report.

### **Avoid Automatic Dissolution**

LLCs may face fines and even automatic dissolution when they miss one or more state filings. When this happens, LLC owners risk loss of limited liability protection. A quality registered agent service can help prevent this outcome by notifying you of upcoming filing deadlines and by submitting reports on your behalf.

If you plan to hire employees, stay compliant with the law by following these steps:

- Verify that new employees are able to work in the US (/hiring-compliance#confirm-eligibility)
- Report employees (https://wi-newhire.com/default) as "new hires" to the State
- Provide workers' compensation (/what-is-workers-compensation) insurance for employees
- Withhold employee taxes (.../../llc-taxes/employee-taxes-for-small-businesses)
- Print compliance posters and place them in visible areas of your work space

# WISCONSIN FOREIGN LLCS

Forming a foreign LLC allows your company to operate as one entity in multiple states. If you have an existing LLC and want to do business in Wisconsin, you will need to register as a foreign LLC. This can be done online

### HOW TO OBTAIN A CERTIFICATE OF GOOD STANDING

A Certificate of Good Standing, known in Wisconsin as a Certificate of Status, verifies that your LLC was legally formed and has been properly maintained. Several instances where you might need to get one include:

- Seeking funding from banks or other lenders
- Forming your business as a foreign LLC in another state
- Obtaining or renewing specific business licenses or permits

You can file a Certificate of Status online or by mail through the Wisconsin Department of Financial Institution.

### DISSOLVE YOUR WISCONSIN LLC

If at any point in the future you no longer wish to conduct business with your LLC, it is important to officially dissolve it. Failure to do so in a timely fashion can result in tax liabilities and penalties, or even legal trouble. To dissolve your LLC, there are two broad steps:

- Close your business tax accounts
- File the Articles of Dissolution
